## **GRAFTON RIVERSIDE FLEA MARKET INFORMATION & GUIDELINES**

- **Market Hours are Saturday 9am-5pm and Sunday 9am-4pm.**
- **Tables & Spaces are assigned in order of product, availability, and payment received.**
- **Spaces are approximately 12' x 12'.**
- **You may bring your own tables.**
- **The maximum trailer height for warehouse entry is 8' 4".**

### **PARKING:**

- **Vendors may not park in spaces adjacent to The Loading Dock. These spaces are for Loading Dock and Flea Market customers. You will be asked to move.**
- **Vendor parking is in field east of warehouse.**

### **LOAD-IN:**

- **Friday: 8am-5pm**
- **Saturday/Sunday: 7am-8:30am**
- **Vendors must be set-up by 8:45am**
- **Your space must be claimed by 8am on Saturday or it will be resold; no refunds will be given.**

### **LOAD-OUT:**

- **Sunday 4pm-7pm**
- **Vendors must be packed before driving your vehicle into the building.**
- **Vendors who cause damage to others will be responsible for damages.**

### **TAX:**

- **As required by Illinois Law, with the exception of your email address, the information you provide to us on this form is shared with the Illinois Special Events Unit.**
- **The Riverside Flea Market is not responsible for reporting monthly sales to the State of Illinois.**
